RULES AND REGULATIONS

TEAM TOURNAMENT (TWO PERSONS PER TEAM, ONE TEAM PER BOAT)

LIVE WELL AND BAIT WELL CHECK BETWEEN 6:00 AND 6:30

RULES: The following rules for the Tournament will be used. These rules will be interpreted solely by the Tournament Committee and all decisions are final.

TOURNAMENT COMMITTEE: The Tournament Committee shall consist of Springfield Crappie Club Board Members at the tournament.

ELIGIBILITY: All individuals who have paid the appropriate entry fee.

HEADQUARTERS/TIME/DATE: EAST BOAT RAMP SANGCHRIS LAKE MARCH 25TH, 2023

Check-in at headquarters by 6:30A.M.

Fishing time will be from 7:00 A.M. to 2:30 P.M.

TACKLE AND EQUIPMENT: Live bait may be used. More than one pole may be used.

All Illinois Department of Natural Resources Laws and Regulations shall apply.

**ENTRY FEE: Entries received by mail on or before Sunday, MARCH 19 2023 \$50.00 per team. BIG CRAPPIE POT \$ 20.00** No checks will be accepted after MARCH 20TH, 2023. CASH ONLY DAY OF Tournament.

Returned checks will result in immediate disqualification. NO POST DATE CHECKS WILL BE ACCEPTED.

DEPARTURE: Departure will be in sequence in which entry fees are received. We reserve the right to assign flights and alternate hours if necessary.

PAYBACK: 1 SPOT FOR EVERY 5 BOATS WILL BE PAID EXAMPLE 30 BOATS PAYS 1ST-6TH

TIES: Ties, will be broken by the LARGEST BIG CRAPPIE WEIGHED. Big fish ties will be broken by earliest takeoff number.

PROTESTS: Protest must be filed in writing with the Tournament Committee within thirty (30) minutes of the conclusion of weigh-in.

DECISIONS ON PROTESTS: The Tournament Committee will decide all protests. All decisions are final.

PERMITTED FISHING LOCATIONS: Anywhere on Lake Sangchris permitted by the Illinois Department of natural Resources.

TOURNAMENT CANCELLATION: If the Tournament is canceled due to reasons of safety, etc., the entry fee will be refunded.

REFUNDS WILL NOT BE MADE FOR ANY OTHER REASON.

BOAT IDENTIFICATION: A contestant number must be available at all times during the Tournament. Boats may not be trailered during the Tournament. ALL CONTESTANTS MUST FISH FROM A BOAT.

SAFETY AND SPORTSMANSHIP: Safe boating and fishing practices must be observed. Life jackets must be worn during take-off.

Kill switches are recommended. All Illinois Department of Natural Resources Laws and Regulations shall apply. **NO ALCOHOL DURING TOURNAMENT WHILE ON THE WATER**

SCORING: Total weight of Seven (7) Crappie per team will determine winners. Crappie must measure at least TEN (10) inches long.

Any team bringing more than Seven (7) Crappie or any Crappie under TEN (10) inches long, to the scales will be disqualified.

Crappie brought to the scales for weigh-in must have been caught during the Tournament hours by the team bringing the fish to the scales. Any frozen or mangled fish presented for weigh-in will result in disqualification. Contestants must be in sight of their partners during Tournament hours and until they have weighed in. Big Crappie is determined by weight.

BIG CRAPPIE: 1<sup>st</sup> place pays 100% of total Big Crappie Pot collected.

WEIGH-IN LINE: Location of the weigh-in area will be announced the day of the Tournament. No team will be allowed to get into the weigh-in line after 3:00 P.M. **NO EXCEPTIONS.**

OFFICIAL CLOCK: The Tournament Committee shall appoint one of its members to maintain an Official Clock.

The Tournament shall operate on the time frame of the Official Clock.

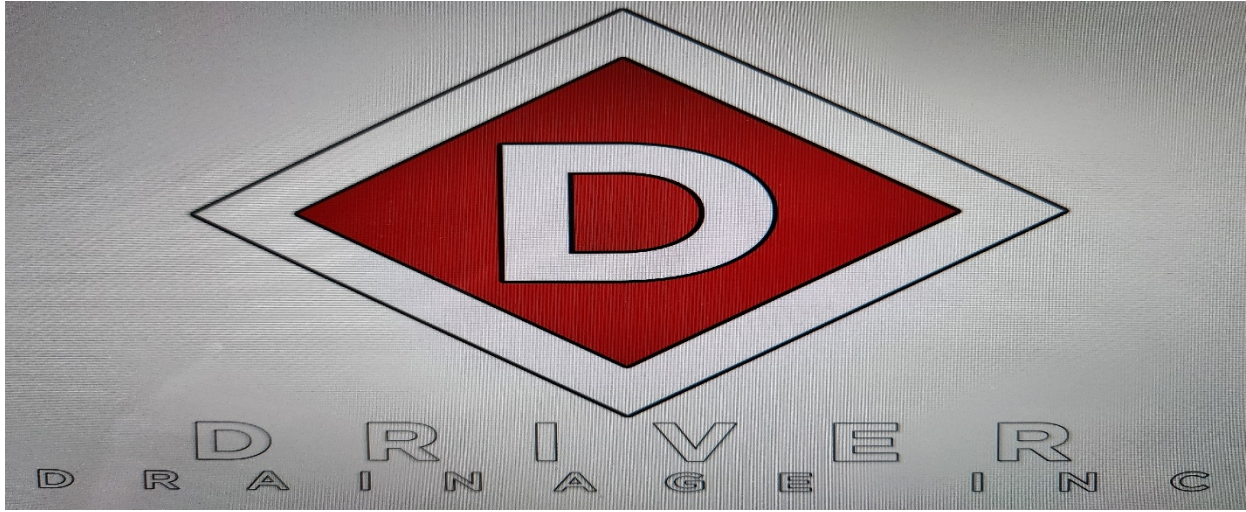
